Market Trend Summary

With 158 new listings and 96 sales, the sales to new listings ratio fell to 61% percent. Inventory levels are up 27% year over year. Sales are up 1.1% percent year-over-year.

Months of supply is up 25.6% year-over-year to 2.35. The average price is down 5.8 percent year-over-year. Average prices were down for all housing types except semi detached which rose 1.7%,

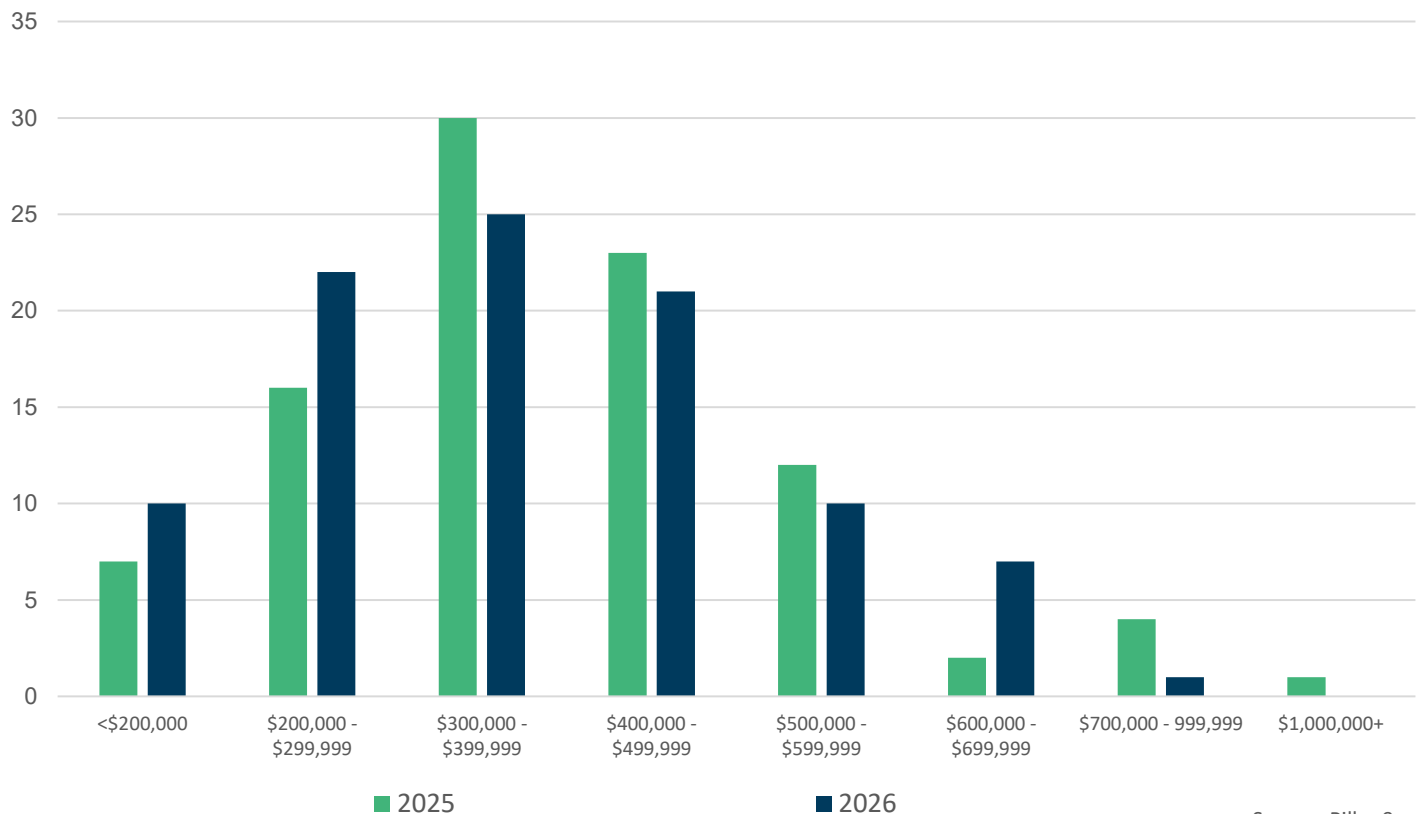
